

**REGULATIONS**  
**of**  
**„Rybitwy” Marketplace, 33a, Półanki street in Kraków**

**§1**

- I. The owner and manager of „Rybitwy” Marketplace, located in Kraków, 33a, Półanki street is Korporacja Gospodarcza „efekt” S.A. based in Kraków.
- II. Rybitwy Marketplace is intended for commercial purposes only.
- III. Only traders and people who paid the required charges can enter Rybitwy Marketplace and park their cars, trucks and cars with trailers there.
- IV. Rybitwy Marketplace is open every day, day and night.
- V. Exact opening hours are set by the Management of Rybitwy Marketplace.
- VI. Information concerning the opening hours of Rybitwy Marketplace is available at Rybitwy Marketplace Office and on the website.

**§2**

- I. Running a business such as: selling goods, catering services and providing services being in compliance with applicable legal conditions and restrictions mentioned in this Regulations is acceptable at Rybitwy Marketplace.
- II. The activities allowed at Rybitwy Marketplace, mentioned in point I., can be conducted by natural persons, legal persons and legal entities with no legal personality.
- III. People conducting on Rybitwy Marketplace premises activities mentioned in point I., are obliged to have valid identification documents and other legal documents stating legality of their businesses.
- IV. Following products are not allowed in door-to-door selling:
  1. unpasteurised milk,
  2. mushrooms and mushroom products, except mushrooms from cultivations or those qualified for sale by the eligible classifier or mushroom expert employed by the Rybitwy Marketplace manager, who is obliged to provide the users of Rybitwy Marketplace with the list of mushrooms approved for selling, producing mushroom products and food products containing them as well as requirements such as certificate given by mushroom classifier or mushroom expert,
  3. Dietary food products,
  4. Bread and cookies without packaging,
    1. Game,
    2. Pharmaceuticals, parapharmaceutical products and intoxicants.
- V. At Rybitwy Marketplace premises, it is prohibited to sell the following products: weapon, ammunition, explosives, pyrotechnics, flammable liquids and gases, as well as alcoholic beverages or pornography (books, magazines, etc.).
- VI. Following products are allowed in door-to-door selling, if special commercial devices or means of transport (adapted and admitted for such sales) are provided:
  1. meat and meat products,
  2. poultry and poultry products,
  3. fish and fish products,
  4. milk and milk products,

5. vegetable and animal fats,
6. Other food products that require protection against improper temperature and sunlight exposure.
- VII. On Rybitwy Marketplace premises, the following actions are completely prohibited:
  1. Drinking alcohol,
  2. Using drugs,
  3. Selling products if seller is drunk or under influence of drugs,
  4. Bringing in external garbage (e.g. from the city, private properties)
- VIII. Selling products through public draws and tenders is prohibited.
- IX. Providing following services is prohibited :
  1. Game of hazard and game of chance at Rybitwy Marketplace (exception: state monopoly and bookmakers),
  2. running massage salons and escort agencies,
  3. running services that cause noises, vibrations and wastes that are toxic to the environment and services that obstruct functioning of Rybitwy Marketplace or is burdensome for the area.

### **§3**

- I. Place and conditions of running business- in the part of Rybitwy Marketplace premises intended for a given type of business is defined by the manager.
- II. It is prohibited to cede the place of running business, if this transaction has been made without a consent and knowledge of Rybitwy Marketplace management.
- III. The management and the users of Rybitwy Marketplace are obliged to comply marking regulating the way of parking vehicles and organizing car traffic on the internal roads in order to make it smooth.

### **§4**

- I. The person running business at Rybitwy Marketplace is obliged to show prices of offered goods and services in a way that is simple and readable.
- II. Person selling mushrooms, qualified by a classifier or an expert, is obliged to place information about the kinds of mushrooms he/she offers.

### **§5**

- I. Measuring instruments used at Rybitwy Marketplace should have proper validation and be placed and used in such a way that could make the customers able to check whether weighing and measuring were made properly.
- II. The seller is responsible for updating the validation of the measuring instruments.

### **§ 6**

- I. Entrepreneurs running a business on Rybitwy Marketplace premises are obliged to maintain the cleanliness and aesthetic appearance of the area where business is conducted.
- II. It is forbidden to store any products and equipment that are necessary to run business outside the designated place, stall, bench, table, etc.
- III. After working hours, given place and its immediate surroundings should be left clean and tidy, and waste and rubbish should be removed to containers intended for this purpose by the person responsible for running the business.

- IV. After working hours, it is forbidden to leave products, trolleys, boxes, other packaging and devices, referred to in paragraph 2 on the premises and in the immediate surroundings.
- V. The owner is responsible for proper storage, ensuring security for products, packaging and equipment located at Rybitwy Marketplace.

#### **§ 7**

Sale of a product; if there are reason to suspect that it is harmful to health, comes from theft or another illegal source of purchase; will be stopped by Rybitwy Marketplace manager, who is also obliged to notify: State District Sanitary Inspectorate, State District Veterinary Inspectorate or Police Station respectively.

#### **§8**

- I. Rybitwy Marketplace has a price list with current charges and:
  - 1. They are paid to authorized collectors,
  - 2. Information concerning its amount is available in Rybitwy Marketplace office,
  - 3. Evidence of its payment should be kept until leaving the premises and shown to authorized bodies during control,
  - 4. Lack of evidence of paying the market charge is treated as its failure to pay.
- II. Rybitwy Marketplace manager is entitled to collect the charge for devices and services related to its functioning.

#### **§ 9**

- I. The management of Rybitwy Marketplace and its users are obliged to obey the Regulations, sanitary - epidemiological regulations, fire regulations and other concerning selling products.
- II. Manager of Rybitwy Marketplace is obliged to supervise obeying the Regulations by its users.

#### **§10**

- I. The owner is responsible for goods, packaging and devices located in the marketplace.
- II. The manager of the marketplace is not responsible for any theft or destruction of products made by third parties.

#### **§11**

- I. Persons violating the provisions of these Regulations and generally applicable law are responsible based on a separate regulations.
- II. For failure to obey the provisions of the Regulations, appropriate financial penalties will be imposed. A ban on entering the area of Rybitwy Marketplace may also be used.
